Martha Griner of Chesterfield, NJ received the Master Judge Emeritus award after retiring from 54 years of judging. She judged three National shows during her career: 1973 in Del Mar, CA; 1975 in Columbus, OH; and 1979 in Grayslake, IL. She also served as co-chair of the judge's training committee in 1974/1975 and chair of the committee in 1975/1976.

Martha began raising dairy goats as a 4-Her in 1956 and became an ADGA member in 1961. Martha is still actively breeding LaManchas with her husband Bill under the Little Orchard herd name. They were honored to be named a historic herd name in 2019 and also to be recognized as part of the ADGA Pioneer program.
