#### FROM THE DESK OF THE PRESIDENT

This national show was the largest in ADGA history with some classes having as many as 125 goats in it. The shows were all very competitive and our judges did an exemplary job utilizing professionalism and critical analysis of the animals. ADGA thrives on the work of its volunteers, and while I know I am not mentioning them all, I must say a fewthanks to Karen Smith our chair for her countless hours of

work in preparing and executing this wonderful event. Thanks to Kris Ellis who was always available at the table to answer questions and get a new card if yours was lost. Special thanks to Trinity Malmanis for her organization of the vet check and to all the people who worked the vet check in the humid heat. Thanks to Sandra Coffman for her work in securing a feast of cheese for the ADGA social event. Prior to the ADGA National Show, our office staff has been busy uploading a great deal of data into our NG accounts. Look for more information in the near future. The first Guernsey registrations have been rolled out, and the awarding of legs and top ten lists are just around the corner. While we have preached patience, I look forward to a time when all is updated and the improved access to all registrations and awards for show, milk records and linear appraisal scores are easily accessible.

ADGA will have a new staff member beginning later in August. Heidi Vanderloop from Wisconsin will be serving as ADGA's Communication and Marketing Director. Heid has a vast knowledge of dairy goats and was able to spend the week in Louisville. Welcome Heidi!

The board of directors passed Postal-Ballot 2324-5 which increases the price of DNA testing. The increase is due to a new negotiated contract with Veterinary Genetic Lab and was discussed at the 2023 Annual Board Meeting. Specific rate pricing will be released by ADGA soon, but these increased prices will not apply to ADGA Plus herds for the remainder of 2024

Finally, the ADGA directorial election is underway. Like the nomination process, each of you should have received an email with your ADGA ID and pin for online

voting. Please participate in the election and let your voice be heard. Paper ballots are available by contacting the ADGA office.

It is my hope that everyone begins planning to meet in Lake Geneva, Wisconsin for the Annual Meeting, October 19-25. The convention organizers have assembled some amazing workshops so we hope to see everyone there!

As I am writing this letter in late July, we have just wrapped up a historic and successful National Show.

Many items will change by the time you receive this newsletter, but I would like to share some positive news in the update below.

#### ☐ Election:

- The primary election voting was an electronic process this year for the first time ever.
- The general election, in progress now, is also an electronic process for the first time ever.
- Ballots must be cast by the second Monday in August (August 12<sup>th</sup>, 2024).

#### ☐ Work Processing Times:

- Turnaround time for work is posted on the website. Please understand that with the phone lines open for most of the business day, the volume of calls has a direct impact on our ability to process work, answer support tickets, etc. Therefore, processing times are slower than we would like to see them.
- Rush orders are currently being completed in 7 business days from the time the order is received in the ADGA office.
- Please note that the USPS is taking up to 7 weeks to deliver mail to us from some areas, based upon the postmarks on the envelopes. We assume that the return mail from ADGA has similar timing. Please plan accordingly and do not wait until the last minute to submit work that is time sensitive. If you have time sensitive work, we recommend that you submit it via overnight delivery and that you request overnight delivery for the completed work.
- Phone lines are open daily. Phone hours are posted on the website. Please select the appropriate department when calling the office. Other departments cannot assist with work outside their department.

#### ☐ ADGA Staff:

 Heidi Vanderloop Benson to be ADGA's Communications & Marketing Specialist. Heidi will join the ADGA team mid-August. This addition to the staff gives us a much needed resource to communicate vital news and information to the membership. We are excited to have Heidi join our team.

#### ☐ Performance Programs:

 The Preliminary Breed Leader list for 2022 lactations is now available to review for DGIR herds enrolled in 2022. The process to put this list together is a little different than in previous years. These records have not yet been accepted into the ADGA database; you will not see awards on the younger animals. We acknowledge that some animals may have been missed through this manual process; if you feel that an animal is missing, please submit a DHIR support ticket and we can research if the animal should be included or not. Please keep in mind the rules for the Top Ten. Animals are required to be on a verification test and enrolled in a qualifying testing plan. The data collection rating needs to be a minimum of 93 and the dry off date needs to be within 45 days of the last test. Those are the most common areas where an animal may be left off the list. Please submit any requests to the support ticket system and choose DHIR as the subject by end of business day on 8/16/24 if you believe there is an error with one of your animals. This list is not official yet.

 We are in the process pushing out 2021-2023 DNA & LA data. You will see in it your NG account when it becomes available.

#### □ NG Programming

- BGS programming in NG is now in place and we have registered the first Guernsey animals. (The Guernsey Breed was granted breed recognition and accepted into ADGA in 2015. Due to the unforeseen difficulties ADGA has experienced with the conversion from ROSS to NG, ADGA has been unable to offer registration services to the Guernsey breed.)
- Legs programming in NG has been completed. We are in the process of reviewing all of the ROA data from 2021 2023 to ensure that it's as error-free as possible before we begin the process of awarding legs. After the ROA data QC is complete, we will start the process for awarding legs with Q1 2021. We will move forward releasing manageable amounts of data. This process and timing will give members time to contact ADGA if an award is missing so that the issue can be reviewed.

#### □ National Show

 On another front, the ADGA National Show was held July 13 - 18 in Louisville, Kentucky. The National Show website, <a href="https://nationalshow.adga.org/">https://nationalshow.adga.org/</a>, has detailed information for the event, including show results.

#### □ Annual Convention

 Please mark your calendars for the ADGA Annual Meeting & Convention scheduled October 19-25<sup>th</sup>, 2024 at the Grand Geneva Resort in Lake Geneva, Wisconsin. Please check the event website, <a href="https://convention.adga.org/">https://convention.adga.org/</a>, for more information. Registration and hotel reservations are open.

#### **DIRECTOR EMERITUS**

Committee considers and evaluates names of retired Directors submitted by members. Nominees must have served at least three terms. Those selected are submitted to the Board of Directors for consideration.

#### **MARY L. FARLEY AWARD**

(maximum one per year)

Awarded to individual, couple or partnership, for outstanding work on behalf of the dairy goat industry. Active members of the Board of Directors are not eligible. Recipient is also awarded a lifetime ADGA membership.

#### **HELEN C. HUNT DISTINGUISHED SERVICE**

(maximum three per year) Awarded to an ADGA member rendering distinguished service to ADGA over a period of years.

#### **AWARD OF MERIT**

Awarded for outstanding service by an ADGA member over the past year.

#### FRIEND OF ADGA

Awarded to individuals and organizations who have rendered special service to ADGA.

#### **HISTORIC HERD NAME**

Selected by Awards Committee and approved by Board of Directors. Criteria detailed in ADGA Guidebook.





#### ■ FROM THE PERFORMANCE PROGRAMS MANAGER

A wave of Performance Programs data, results, and features are coming to NG over the next few months. Recently, the 2021 Linear Appraisal scores have been uploaded. If you were appraised in 2021, the scores are displayed under the Linear tab for the individual goats that were included in that appraisal session. The column labeled PS is for permanent score. The highest score achieved after the animal's fifth birthday will be designated as the

permanent score. We anticipate the 2022 and 2023 scores to be uploaded soon along with a long list of DNA results from 2021 and 2022.

DNA pricing will be changing on 8/1/24. Every three years the agreement between ADGA and Veterinary Genetics Laboratory (VGL) is updated to reflect current costs and available testing services that are being offered to ADGA members. Leading up to the renewal of this contract ADGA sought bids from four different vendors to ensure that the membership was receiving the best combination of access to available services in the marketplace and the best price point. Order submission, result turnaround time, result database infrastructure, and access to the current DNA and Diagnostic tests we already have were all considered in seek-

ing the next DNA vendor agreement. After all bids have been accounted for VGL will remain as our DNA services provider for the next contract. We anticipate a change in pricing to take place around August 1, 2024. We will have another communication soon with the prices for each test type. If you have animals that you have been meaning to sample, there is still an opportunity to order your tests at the current ADGA rates. You can also expect the DNA ordering process to change slightly over the next few months. The programming is in place for DNA requests to be processed from your account without having to go to the jot-form and wait for an ADGA staff member to process your requests.

DHIR is also getting some attention inside NG. The 2022 preliminary Breed Leader list has been sent out to the 2022 DHIR herds. We will finalize that list and start work on the 2023 list. You may have received a transaction receipt for a previous DHIR year enrollment. That is ADGA updating your account to bring your DHIR enrollments, test plans, and verification tests up to date. Testing has been underway in the background to bring in the accepted milk records that can be displayed in your account. There will be an announcement once the records have been imported.


